

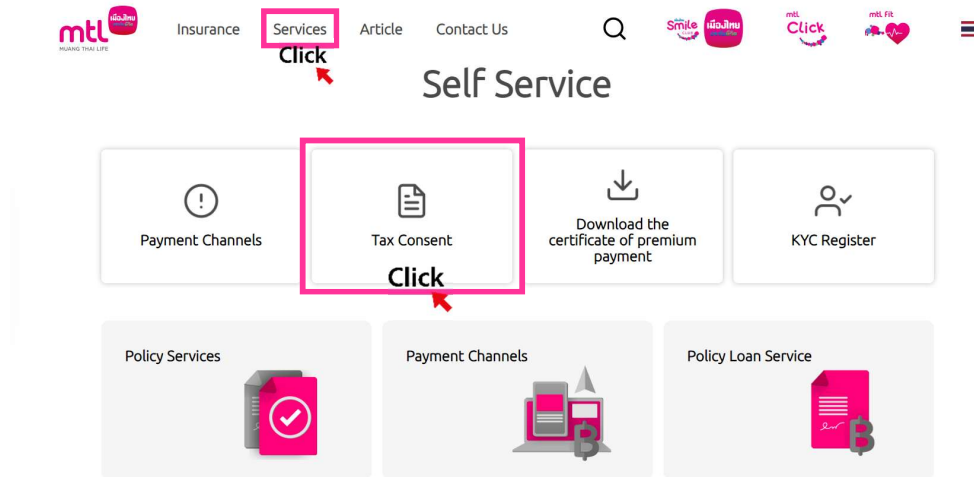

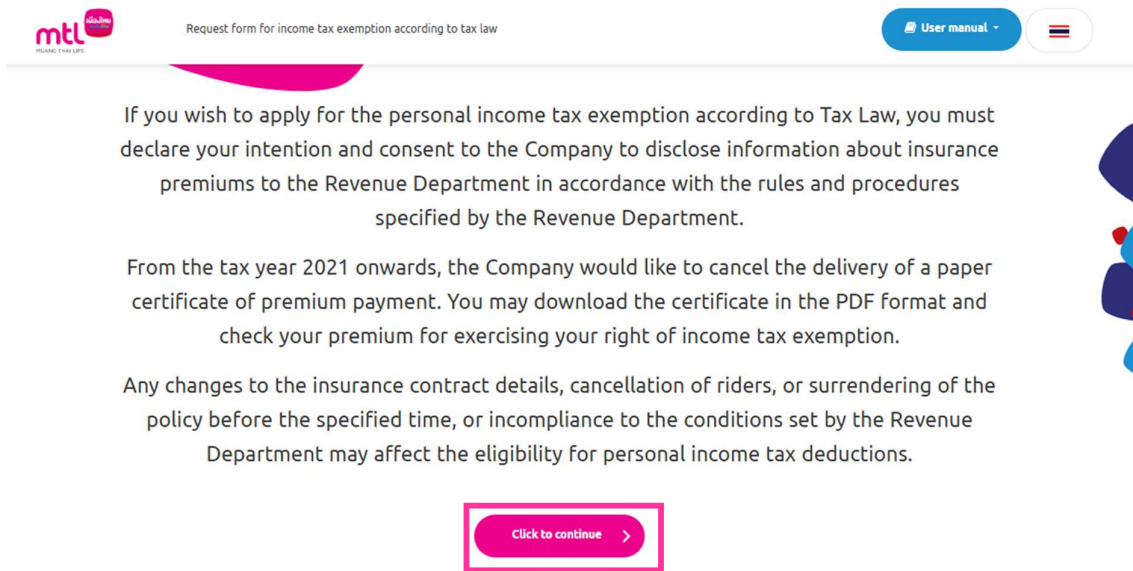
1. How to log in for tax consent declaration

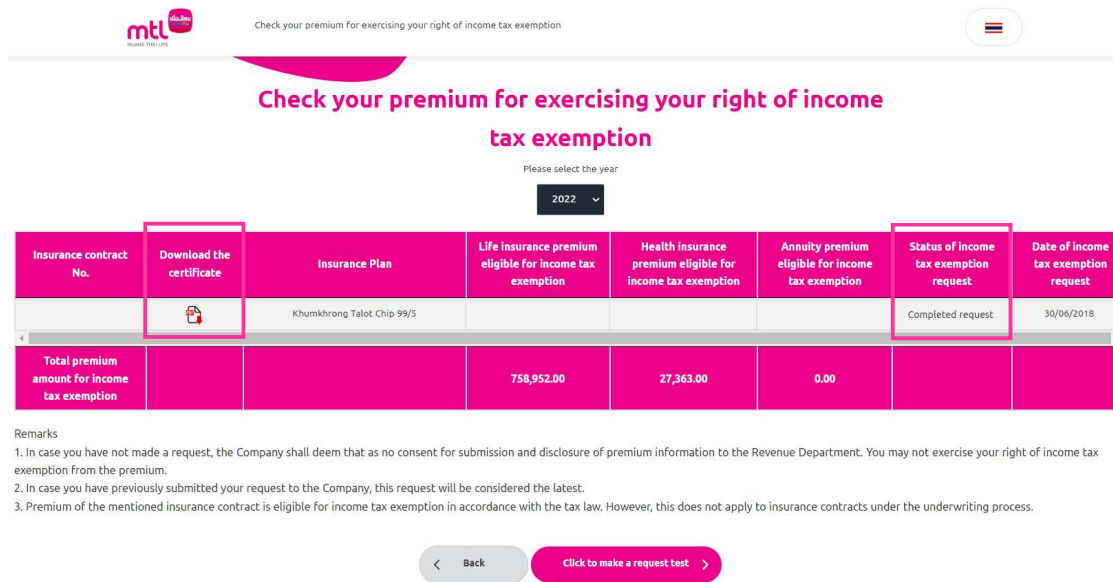
