

# Announcement

## Amendment to the Mutual Fund Project of 9 Funds under Management



Krungsri Asset Management Company Limited (“the Management Company”) would like to notify unitholders of the amendments related to the change of Fund Code and Share class Code for 9 mutual fund projects, namely: Krungsri Asian Income Hedged Fund (KFAINCOM), Krungsri Collective Global Income Fund (KFCINCOM), Krungsri Global Collective Smart Income Fund (KF-CSINCOM), Krungsri Global Multi Asset Income Hedged FX Fund (KFMINCOM), Krungsri Global Smart Income FX Fund (KFSINCFX), Krungsri Global Smart Income FX RMF (KFSINCFXRMF), Krungsri Global Smart Income RMF (KFSINCRM), Krungsri World Equity Index Fund (KFWINDX) and Krungsri World Equity Index RMF (KFWINDXRMF), which have been approved by the Office of the Securities and Exchange Commission (the “SEC Office”).
